INTERIM SUPERINTENDENT'S REPORT

Dr. Alvarez made the following statement:

Dr. Alvarez noted that for a number of weeks, the District has been discussing the possibility of returning kindergarten and grade one students to a 5-day per week program. There were

concerns raised by the teachers union that the District was resolving. He announced that kindergarten and grade one students will have the opportunity to return to 5-days per week of instruction beginning Monday, November 16.

He confirmed that all kindergarten and grade one classrooms will require all students to wear masks, as per state mandate; provide each student with an individual desk; provide each student with an individual desk shield; and allow for social distancing. In addition, needlepoint bipolar ionization technology has been installed in all kindergarten through grade 8 classrooms.

Dr. Alvarez reported that a majority of River Vale families have opted to have their children return to a 5-days per week program. He also thanked the Board for their willingness to affirm the administration's recommendation.

In other matters, he noted the Board Resolution to approve a new bylaw regarding *Remote Public Board Meetings During a Declared Emergency* and stressed that the one reading adoption is in compliance with the new emergency regulations regarding remote meetings held during a Governor-declared emergency.

Finally, Dr. Alvarez congratulated Mrs. Pintarelli, Mr. Rosini and Mr. Schlereth on their reelection to the River Vale Board of Education.

BOARD SECRETARY'S REPORT

Ms. Ippolito advised that the November 17, 2020 Board Meeting could possibly be moved to November 24, 2020.

WHEREAS, each district will be expected to develop, in collaboration with community stakeholders, a plan to reopen schools in the fall that best fits the district's local needs; and

WHEREAS, the District did develop, in collaboration with community stakeholders, a plan to reopen schools in the fall that best fits the District's local needs;

WHEREAS, the District shall amend the District's Restart and Recovery Plan a second time, effective November 16, 2020, to accommodate the return of students in grades K and 1 to a 5-day per week program; and

NOW THEREFORE, BE IT RESOLVED that the Board hereby approves the amendment to the District's Restart and Recovery Plan which was submitted to the Department of Education on July 29, 2020, amended October 13, 2020, and to be implemented effective November 16, 2020 for the 2020-2021 school year.

Edward Salib, 562 Faletti Way: I would like to participate please. Thank you for allowing, bringing the K-1 grades in 5 days a week, to work.

Was installing the needlepoint bipolar ionization systems in every class room a prerequisite?

Interim Superintendent Dr. Alvarez: No it was not.

Edward Salib, 562 Faletti Way: Is there a next step? What is the County Meeting being held in December?

Interim Superintendent Dr. Alvarez: Stated that the District will proceed with caution and continue to be guided by the Health Professionals and State guidelines.

School Business Administrator Ms. Ippolito: Stated that there is a County Chapter of the State Board Member Association that hold County Round Table meetings for workshops and continued education for Board Members.

Marla Giummarra: Hi - Please try again. Marla Giummarra. Thank you

School Business Administrator Ms. Ippolito: Maria, please sign off and back on. Thank you.

Marzena Santos, 747 Rolling Hill Drive: Hi, Bergen County is at a 5% increase in positive test rates, today. At what percentage will schools be closed down? As much as I want my kids to go back to school, this is scary.

Interim Superintendent Dr. Alvarez: There is no magic number, we are guided by the Health Professionals and State guidelines. The District will make a decision on a case by case basis.

Marla Giummarra: 3 times a charm? otherwise I can just type my questions

Marla Giummarra: Two things - Can you please explain the benefits of the current desk shields? Apparently they are thin, cheap plastic and they fall multiple times a day.... Can you get plexiglass or acrylic like other Bergen schools and every grocery store in the state?

School Business Administrator Ms. Ippolito: The desk shields are for better or worse, sneeze guards and we took into consideration the weight as the plexiglass shields can weigh anywhere between 5-8 lbs and when the students need to lift the tops of their desks to retrieve their materials, the heavy desk shield becomes problematic. We also wanted to balance the cost. We asked the teachers for input and know that other surrounding districts are using these same desk shields.

Marla Giummarra: How are they sneeze guards if they fall every other minute?

Marla Giummarra: Don't the teachers have enough to worry about?

Marla Giummarra: My son is a 5th grader They are garbage and they gall

Marla Giummarra: fall

Marla Giummarra Doesn't a mask hold the sneeze?

School Business Administrator Ms. Ippolito: Yes, however we decided to provide an extra layer of protection for the staff and students.

Marla Giummarra: For the spike after Thanksgiving are you providing or requiring teachers and students COVID testing?

Interim Superintendent Dr. Alvarez: No we are not.

Marla Giummarra: What are you doing to proactively plan for this?

Marla Giummarra: Why

Interim Superintendent Dr. Alvarez: The District will proceed with caution and continue to be guided by the Health Professionals. Guidelines are changing depending on the number of cases.

Marla Giummarra: So you are just expecting a spike with no plan?

Board Trustee Puccio: It is my understanding that you can't just unilaterally decide to shut down the schools. Isn't that the case Dr. Alvarez?

Interim Superintendent Dr. Alvarez: That is correct. We need to follow the protocols from the Department of Education and Health Professionals

Jody Edwards, 603 Westwood Avenue: Students are not as vulnerable how does this work?

Interim Superintendent Dr. Alvarez: Average class sizes are 10-13 students with one class having 19 students. We feel we can provide a safe environment for staff and students.

Jeff, No Last Name or Address: Hi-as a new family to the district with a child in kindergarten, we just wanted to send our sincere thanks for listening to our concerns. It is refreshing to know that we are being heard and our voices are valued. We know our kindergarten student will greatly benefit from the 5 day in person instruction. (no need to call on us)

Interim Superintendent Dr. Alvarez: Thank you

Erica Ban, 521 Track Lane: Just want to inquire about the afternoon schedule at Holdrum. Is there any possibility of having some sort of academics after lunch? Even if it is not a formal class but some sort of enrichment academic club.

Interim Superintendent Dr. Alvarez: We are continuing to look at all aspects of our schedules. Teachers are still working and provide support to students after lunch. Not all students need the time with teachers but we are continuing to review and modify as necessary.

Marla Giummarra: Is it fair to be given report cards in these atypical times? How accurate can they really be?

Ines Fajardo: why are people being so rude

Amy Dahl, 608 Abbe Ct: What is the policy for when parents have Covid? What do you do with the children? Do you send them in?

Interim Superintendent Dr. Alvarez: If the parent is ill, we advise keeping the students home. If it is a confirmed COVID case, the student must quarantine for 14 days.

Joe Levinson, 268 Rockland Avenue: It has become evident this board had NO plan, and just reacts to events.

Joe Levinson: They could have huge liabilities in the legal sense by having no plan.

Ines Fajardo: ok, got it. thank you

Jody Edwards, No Address: what about remote kids?

Interim Superintendent Dr. Alvarez: Teachers are involved and students will continue with their regular classroom teacher.

Edward Salib: 100% safety is not possible. Thank you for making measured decisions in the best interest of our children and remaining flexible with your plans.

Edward Salib: *best

Board President Waldes: Understand that this is a hot button item. I assure you that we are doing all that we can to keep your children safe. Never doubt the sincere concern and commitment we have to do what is best for children.
